

Terms of Service

By agreeing to the Terms of Service you (Website Purchaser or Client) agree to the policies and terms set forth below by TeriGrowth, a Kentucky Limited Liability Company.

1. Fees

- a. Website Setup fees for services performed under this Agreement, regardless of the services provided shall be based upon the rates provided below unless a flat fee or other arrangement is agreed upon in writing:

Website Setup	\$375 + Tax + Processing Fee
Website Maintenance	\$30/month + Tax + Processing Fee
Special Pricing	Mutually Agreed Upon + Tax + Processing Fee

- b. Clients will be given the first month of Website Maintenance for free upon purchase of the 'Website Setup' service.
- c. Such rates are potentially subject to change January 1 of each year or earlier upon agreement of the client and TeriGrowth.

2. Billing

- a. TeriGrowth, LLC will bill Client for all fees, charges, costs and expenses immediately upon checkout (Website Setup) and every (30) days (Website Maintenance).

3. Costs and Expenses

- a. Client acknowledges that TeriGrowth may incur various costs and expenses in connection with the 'Website Setup' and 'Website Maintenance' Services.
- b. TeriGrowth shall charge the client's payment option directly for such costs

4. Binding Effect

- a. Client acknowledges that the Terms of Service is binding on them, individually and collectively and on their successors and assigns, and is likewise binding upon TeriGrowth and its successors and assigns.

Refunds

1. Website Set Up

- a. Once the project timeline for the development of the 'Website Setup' service is agreed upon between the Client and TeriGrowth,LLC - the premature cancelation of a project will result in the client being issued a 20% refund of the total amount paid for the website before tax and processing fees. Once the website development project has been completed, a full refund will be issued until 2 days after the completion of the website. After the 2 day refund period, refunds will not be available.

2. Website Maintenance

- a. As stated above, upon completion of the 'Website Setup' Service the Client will receive the first month of maintenance for free and will be given a free month of website Maintenance for every paying customer that completes a 'Website Setup' Project. Website Maintenance fees are non-refundable. In the event of a cancelation, clients must provide a written notice a minimum of 14 days prior to billing due date.

Cancelation by TeriGrowth

1. Canceling Service

- a. TeriGrowth reserves the right to modify, suspend or terminate service for any reason without notice, at any time.
- b. Upon Cancelation of the Website Setup Service by TeriGrowth, a full refund will be sent to the Client.
- c. Upon Cancelation of the Website Maintenance Service by TeriGrowth, a refund of the dollar amount per day depending on how many days the Client has left in their month of service will be issued.
